From the Charter Amendment Resolution:

For the purpose of altering certain provisions of the Aberdeen City Charter to reallocate certain powers, duties and responsibilities of the City's Mayor, City Manager and City Council in order to provide for what is commonly referred to as a Council-Manager form of government; altering certain provisions regarding the appointment and terms of office of the City's Board of Election Supervisors; and generally related to revisions of the City's structure of government.
